



## FEE INFORMATION SHEET

(Effective August 1, 2017)

### Speech & Language Evaluations

All evaluation prices are inclusive of a post-evaluation parent conference as well as a formal written evaluation report documenting test results and an interpretation of those findings, including diagnostic codes. Evaluations are scheduled in the office. Required additional testing is billed at the hourly rate of \$130.00. We offer several different evaluations depending on the needs of your child:

**Comprehensive Speech and Language evaluation (ages 4+) - \$650** - includes up to 3 hours of testing

**Comprehensive Speech and Language evaluation (under age 4) - \$400** - includes up to 2 hours of testing

**Comprehensive Speech and Language evaluation (under age 2) - \$200** - includes up to 1.5 hours of testing; evaluation based on parent report plus direct therapist observation/interaction

**Augmentative Communication Consultation and Evaluation - \$250-\$650** – pricing dependent on whether system is in place, previous evaluations, etc.

**Apraxia Evaluation - \$450 (without formal language assessment); \$650 (with language assessment)** –includes up to 2 hours of testing

**Articulation / Oral Motor Evaluation Only - \$200.00** for children 3 years and older.

**Feeding Evaluation - \$130-200.00** - This evaluation is individualized for every child depending on the needs of that child. A brief written report and home programming ideas are always provided regardless of whether regular therapy is recommended.

**Fluency Evaluation - \$200**

### Speech and Language Therapy

\$130.00 per hour – office

\$140.00 per hour – home/school\*

\$100.00 per ¾ hour – office

\$110.00 per ¾ hour – home/school\*

\$68.00 per ½ hour – office

\$75.00 per ½ hour – home/school\*

\*Home/School therapy is provided only as our overall caseload permits – rate is for those sessions within a 5 mile radius of our clinics.

\*\*A 10% off sibling discount is available for 45 minute-1 hour individual, on-site, ST, OT or Tutoring sessions as well as for 1 hour social duo groups run by one therapist

**Actual duration of a therapy session incorporates 5-15 minutes for parent conference and therapist documentation. Actual time with child will be less than scheduled session duration (i.e. a one hour session includes 45-50 minutes of direct time with the child and 10-15 minutes for conference, clean up, billing, etc.)**

Therapy fees include periodic telephone consults with associated therapists and/or teachers to discuss the child's therapy goals and progress. One progress report is provided per six-month period without charge.

Speech and Occupational Therapy co-treatment is available using the above fees for Speech plus the additional fee for Occupational Therapy (in office only).

### **Group Speech and Language Therapy**

\$100.00 per hour – 2 children

\$60.00 per hour – 3+ children

Combined Speech and Occupational Therapy groups are also available and billed at \$110.00 per hour (Coded as \$55.00 Group Speech + \$55.00 Group OT for insurance purposes)

Summer groups are often billed ahead for the duration of the summer.

### **Tutoring**

\$90.00 per hour – office

\$100 per hour – home/school

\$70.00 per ¾ hour – office

\$80 per ¾ hour – home/school

### **Consultation - \$130.00 per hour**

Consultative services are available for those families who request periodic input regarding a child's speech and language development, school progress, use of augmentative communication systems, and for the development of appropriate home programs. Consultative services are also available at the child's school or daycare setting.

### **IEP Development - \$130 per hour**

IEP development and planning services are available to families needing support through the IEP / special education process. Therapists will also attend IEP meetings as requested and at the regular hourly rate of \$140/hour.

**Additional Fees:** Copies of invoices and treatment notes are provided at the end of each session for your records as well as to provide to your insurance company as needed. Additional copies of these items are billed at \$0.50 per copy for the first 50 pages and \$0.25 per copy after the first 50 pages. Also any reports generated for insurance purposes will be charged a fee of \$10.
